The Presque Isle Harbor Property Owners Association provides, by volunteer committee, a security program for your convenience. This program is offered in the spirit of good neighbors promoting a safe and harmonious environment in our community. Your property or camper can be included in the program for a small donation to cover expenses.

A twice-weekly random check of the exterior of said premises will be made to determine the condition. Problems will be reported to the Association Manager and Property Owner. The Security Patrol will not check the residences or campers while the members are using them. It is the responsibility of the owner to notify the Security Committee when they will be gone.

Property owner should keep the property accessible at all times. Snowplowing of driveways not only helps to improve Security Patrol access, but it is an asset for fire protection and fuel deliveries as well.

Please inform Clubhouse Office (989-595-2411), if you leave a "RED" low temperature lamp in your window. Also, low temperature lamps should be set 10 to 15 degrees lower than the house thermostat.

The Security Committee cannot accept keys to member's houses or campers. Owners may make arrangements with individual Associations members to have keys to their property, understanding that this is not a function of the Security Patrol. With respect to Presque Isle Harbor Association, Inc., neither it nor its officers, directors or employees assumes any contractual liability for loss or damage with respect to activities of the Security Patrol.
