V. Fields received a comment that repairs to our buildings should be fixed by local companies.

 - Campground cabin area of the campground is nearing completion for the sight work. Gravel is installed and septic sewer pipe will be installed, and Thunder Bay Electric will hopefully be running the electric to it.
 - The Clubhouse lost power and internet the past week. The drain came off the pool, the pool was drained to fix the drain. Cleaned and made needed repairs to the pool filter.

Storm Damage – Ventilation issues were discussed between J. Kroll and MVP in the pool area. There is no set timetable as of yet, as it depends on what the insurance company does.
