## **Property Owner Comments:**

- Ice cream social was great, good turnout, potluck the next day was great also
- Remarks about North Bay has no signage at all and needs to be there. Questions about what needs to go on sign; dogs allowed, members only, no motorized vehicles, dogs on 6ft leash
- Concerns of a non-member "trapped" at Crystal Point, signs will be going up
- Comment to form a subcommittee to create signage lingo
- Suggestion to add more boulders, issues with golf carts on the beach
- Concerns with 5-year pool plan; M. Ulrich commented the 5-year plan was a recommendation by Strayle, not the Board, nor Jacob.
- Comment about campground fire ring, ID cards are an inconvenience to come get one for a family member, suggest spending dues on upgrading campground showers
- Great experience in the campground
- Question on Board appointment after a resignation with it being a Board responsibility and has full discretion
- Remark about proxy ballots that there is no option to check no, Jacob confirmed it has to follow by-laws

**Financial Report:** V. Fields reported CD's are doing very well due to interest rates. *Motion to approve financial report as presented (D. Larkin/D. Fauver)* Discussion ensued. Ayes All. Motion carried. *Motion to approve C. Campo request of paying Kristie Lukes \$150 for recording Annual Meeting minutes (V. Fields/D. Cleary)* All Ayes. Motion carried.

**Immediate Family Status:** Lengthy conversation regarding in-laws. Referred to the Rules committee. No changes to the present definition of "immediate family" currently.

**GLB Boat Slip Rental:** The committee has 2 members, Brad Mathis added tonight. They will have a meeting next week and announce it on social media to encourage more members to join.

**Election Results:** M. Ulrich explained per Article 4 of the By-Laws, the top 3 candidates will be declared new members to the Board. There is no reason to publicize results and the Board will not release the counts. If there is a vacancy on the Board before the next scheduled election, the Board has the authority to fill that vacancy at their discretion.

**Maintenance:** Jacob gave an update on ongoing maintenance projects. May 2022 storm damage: MVP will be here next week to update schedule.

**Payroll Service:** Search for a new paycheck system with V. Fields and M. Ulrich to assist in the process. There is an advisement to go to payroll service however, at this point, there is no need to change as more analysis is needed.

The protocol for pool closing was explained by Jacob.

A questionnaire was passed to the Board with discussion on changes, where to post, etc. Jacob will also follow up with a pool tracking system.
