

Hello PIHA:

Our April Board meeting was well attended with questions regarding ATVs on our trails, Board Meeting Agenda, new membership cards and the Merry-Go-Round at the campground, which Jacob stated our maintenance crew will look at it.

The Financial Report and Meeting Minutes from March were approved. You can find meeting minutes on PIHA website. Copies of the financial report can be obtained from Jacob.

A 2nd dues notice was mailed out on April 15th. If you have not received your dues notice, please call the clubhouse or email memberservices@presqueisleharbor.org. You can copy that email to any board member if you wish. Late fees will go into effect on May 1st.

Over 300 new ID cards have been issued. As a reminder, you will be required to show valid identification (such as a drivers license) and have your picture taken for the card. The front desk attendant will also be updating all contact information. This new membership card is required to access the clubhouse. In the near future, it will be required to access all association facilities.
