Spring has Sprung!! But tell that to mother nature who keeps sending the snow and crazy wind!

Thank you to the members that attended our March board meeting and shared their concerns.

Steve Lang was a guest speaker and informed us about some zoning changes that need to be researched for the common areas of PIHA. He will be meeting with volunteers from PIHA to address this issue.

Hail damage & MVP update: The only work remaining on buildings (except clubhouse) is gutters and painting of GLBH. The window for the craft room should arrive in about 3-5 weeks. As I have written before, the clubhouse has a number of issues: replacement of HVAC, roof and siding. Not only is the roof over the pool causing a delay, but updated codes for replacing the HVAC is also complicating our progress. Jacob continues to work closely with MVP and the insurance adjustor to reach a resolution to our issues.

Over the last couple of meetings, the Rules Committee has recommended some changes to our Rules. Changes were suggested to the Board and the following have been approved:

Rule 3 b: Expands 'immediate family' to include children's spouses. This resolves the issues of daughter and son-in-laws having access.

Rule 8: Minor changes to reflect membership card versus previous identification cards.

Rule 8 s: Clubhouse hours are determined by the board. NEW RULE

Rule 22: **NEW** statement inserted within the existing rule stating that no more than one member of an immediate family can serve on the Board of Directors. Also some language change was approved.

Rule 31 I: MEMBER INTERACTIONS WITH PIHA VENDORS. If a non-board member contacts a PIHA professional Service (IE: PIHA Attorney or Accountant) or a PIHA vendor and incurs a cost, those costs will be billed to the member and must be paid to remain in good standing. **NEW RULE**

At this time, you are not able to print rules, by-laws, restrictive covenants off the website but copies are available at the clubhouse.

Committee Updates:

Clubhouse, Beach & Pool: Based on member input, this committee is gathering options for a kayak launch and paddleboat lift at Grand Lake Beach. Watch for additional information next month.

Pool Committee: This committee is planning a membership meeting over Memorial Day and the 4th of July weekends.

National Resources: Has a trail clean-up scheduled for April 21.

Social Activities: Blood Drive on March 26 and Easter Egg Hunt on March 30. A complete list of activities can be found on our website: <u>www.presqueisleharbor.org</u>. There is also a current list of activities on the bulletin board at the clubhouse.

On a more serious note, Facebook continues to be an issue within our community with disinformation and unnecessary criticism of our Executive Director, Staff and Board members.
